
### CONSTITUENCY OFFICES (2ND PHASE) – USE OF ICT






Internet has changed attitudes and expectations. People want the policy process to be open, transparent, more accessible, more participatory...

- To strengthen the Legislative, Representative and Oversight Role of MPs


